NATIONAL PARKS

Efforts are still ongoing in the campaign for reduced entry fees, but a reply is unlikely until the N.P.'s commission has completed its report. Interestingly, in the period up to the time park fees were introduced, the R.M.N.P was the most popular park in the country, with Victoria Falls a distant second! The present rains have averted a potential crisis in game management in the park as water was becoming very scares. The refurbishment of Maleme Rest Camp is ongoing.

NATIONAL MUSEUMS

The Adopt-a-cave effort is progressing slowly. If any member wishes to help, please contact the Secretary. We require a person to act as co-ordinator between N.M.M's and the various donors, not a very onerous function at all, and certainly interesting.

NATURAL RESOURCES BOARD

Approaches have been made to the N.R.B. to have the Lumani Tree Ferns protected, and to enquire as to the extent of streambank cultivation and deforestation (particularly of Mukwa trees) on some farms and around the Mshashasha Valley in the Eastern Matopos.

FIELD DAY MEETING

On 30 October 1994, about 25 members travelled to the Mtshabezi Valley and the site of the recently completed Z\$35M dam. This was an all-day event and most of us were equipped with spades and forks to facilitate the listing of small plant species such as aloes, orchids and ferns from within the dam area (which will be flooded) to above the dam wall. Of particular interest was the discovery of a new colony of the rare Osmondo Regalia Fern (only the fourth known colony) which has been removed. The ferns appear to have "settled" in their new home. This was a hot, but very interesting day. A further visit to the site is planned for later this year.
