## 1 - MATOBO COMMITTEE REPORT

The Matobo Committee, which, with the Department of National Parks, is responsible for the administration of the Matobo National Park in terms of the Rhodes Trust, invited a representative of the Society, and of similar bodies such as the Wildlife Society, Ornithological Society and the Rapture Research group (Black Eagle Survey) to a meeting of the Committee at the Parks The intention is to hold these meetings quarterly, as they provide a forum at which matters affecting all interest bodies can be openly discussed - and resolved! This will give the various bodies an opportunity to make a meaningful contribution to the Park, and a better understanding of its operations, which in turn should go a long way to eliminate the level of frustration that has been experienced to date.

Specific details from this meeting are noted elsewhere in this newsletter, but there are many exciting developments planned for our Park. These include new camps, new lodges, possibly a restaurant at Maleme, and an Interpretive Centre at Sandy Spruit. All paid from the gate monies that have been collected! We will play an important environmental role in all this development.

# 2 - MATOBO NATIONAL PARK BROCHURE

Our new brochure is at the printers, and examples should be available at the AGM. A further 5,000 copies of the popular Rock Art Brochure have been reproduced, and will be mad' available from Sandy Spruit, Pomongwe Cave and Maleme Rest Camp. It is intended to place laminated copies of both of these brochures at major visitor sites, subject to official approval.

## 3 - LITTER BAGS

The litter bags that have been supplied by PROCON SALES are available upon entry into the Matobo National Park at Sandy Spruit. However, please ask the National Parks Staff for a bag as it seems they are not being offered as intended. Your committee will discuss this with the Park warden in due course.

Some good news is that Parks are aware of the present delays in purchasing tickets, and intend to introduce a revised, mechanical means of providing tickets at Sandy Spruit. Electric power has been provided at Sandy Spruit to facilitate this development.


### 9 - WALKING IN THE NATIONAL PARK

This matter was discussed at length with the authorities, and it was finally resolved that any person wanting to walk anywhere in the Matobo National Park must advise the nearest warden or ranger of your intentions before setting off. You may be asked to sign an appropriate book. Please co-operate in this matter, as it will save us all a lot of trouble in the long run. Designated walks, i.e. to Inange cave, or walks close to picnic sites, do not require prior notice.

## 10 - COMPLAINTS

We frequently receive complaints from members and the public about matters in the park. Please refer these first to the warden or ranger on duty so that action can be taken immediately to rectify the matter. If necessary, then write to the Warden, Matobo National Park as it is his responsibility to resolve these matters. If you feel that there is then no satisfaction, please copy the complaint to the Society. In this way, complaints will be dealt with a lot more appropriately.
