# 6 - REPORT BACK

Only two teams with a total of 7 members participated in the event, which was unfortunate. As a consequence, not all sites were visited, but the balance of sites are being included in subsequent fieldwork so as to complete the exercise. For those who attended, the survey was both interesting and worthwhile, and the weekend was made all the more fun as it coincided with a wet spell. Consequently, the hills were in a spectacular condition. The teams spend the night on the farm Shumbashaba Mkulu, staying in converted stables and enjoying an evening braai where tales of the day were swapped. There were mixed results, with some alarming damage to rock art being reported, but also some remote sites being found without trace of any damage. The teams were armed with GPS equipment so as to record exact positions for future surveys, and the experience gained will assist with the planning of similar tasks in future.

# 7 - CHEETAH SURVEY

A study of cheetah at Chipangali will be undertaken in late January. Members are offered the chance of being part of the observation team, which will entail observing the animals for pre-determined periods from a platform. (Somewhat like a Game Count). #### 8 - APPEAL FOR HELP

The committee believes that the society requires professional legal advice if we are to put pressure on various bodies to perform in accordance with the statutes presently in existence that regulate environmental management and control. If pressure is to be exerted it is important that we are able to quote from the relevant statutes when making our presentations, and it seems that at present environmental legislation is to be found in a great many different statutes. The society has a number of copies of various acts in its records, but we are sure that these are incomplete. Of interest is the proposed formation of an Environmental Law Association, established between Environment 2000 and the CZI. Assistance or advice from any of our legal minded members on this topic would be appreciated.
